Supervision ratio is 1 instructor to 1 class plus one additional instructor nearby. There is no requirement for an additional adult. Instructor to be trained to in-house syllabus. Refresher training as directed by session observations. The school is responsible for grouping the pupils with a supervising adult.

| Road Accident Crossing the Village Road A614 | All | | <ul style="list-style-type: none"> • All participants are required to wear yellow high visibility jackets at all times whilst in the village. • Staff and adult helpers are distributed evenly along the line of children whilst walking, and one adult, preferably the activity leader, must always be at the front, with another at the back. • Crossing the road is only undertaken at points where visibility is clear and safe. • The preferred crossing method is to line all the children up side by side on the path, and cross them all at once with staff and adults to act as crossing patrols at both ends of the line. • Staff and adults should be aware of all those pupils placed under their supervision. Centre staff should not be included in this provision as they are in overall charge of the activity and should only be involved in its safe control. • Children who behave in an unacceptable and unsafe manner will be | medium |
